The Principal Secretary, Higher Education (J) Department in the meeting held on 02.06.2012, regarding fixation of fees-MTech courses conducted by LBS & IHRD, has decided to allot 25% of M.Tech seat in each branch for sponsored candidates of which 1 seat in each branch will be set apart for department candidates. The department candidates shall undergo M.Tech by availing either eligible leave or LWA for the entire duration of course. No fee shall be charged from department candidate. The department candidate shall execute a bond in the prescribed format (attached), stating that they shall serve the department at least for 5 consecutive years immediately after completion of M.Tech course.

Applications in the prescribed format (attached) are invited from teaching staff under IHRD who had completed 2 years regular service under IHRD. The employees who complete 2 years regular service under IHRD as on 20.07.2012 alone are eligible to apply under the scheme. The maximum age limit to apply under the scheme is 45 years as on 20.07.2012

The order of preference of applications for selection will be.

- 1) Teaching faculties of Engineering Colleges of the same branch in IHRD
- 2) Teaching faculties of Polytechnic of the same branch in IHRD

- 3) Teaching faculties of College of Applied Science of the same branch in IHRD
- 4) Teaching faculties of Engineering Colleges in other branches in IHRD
- 5) Teaching faculties of Polytechnic, College of Applied Science in other branches in IHRD

The last date prescribed for receipt of application in the prescribed format by heads of institutions is fixed as 25.07.2012. The applications so received by Principals of institutions shall be forwarded to this office duly verified and recommended so as to reach here on/before 27.07.2012.

Late applications will not be considered under any circumstances.

- (b) not conforming to the rules and discipline of the Institute of higher studies or
- (c) applying for any post or sitting for any all India or State Government competitive examination during the course of higher studies, or
- (d) failing to intimate to the Government the amount and other particulars in respect of any honorarium of other monies earned by him during the period of his higher studies as above, or
- (e) refusing to hand over and surrender to the IHRD the whole or part of such honorarium of other monies received by him as aforesaid, if and when required to do so by the IHRD, or
- (f) getting adverse report regarding the progress of his/her studies or regarding his/her conduct in and outside the place of higher studies, or
- (g) failing to complete the higher studies successfully as aforesaid, or discontinuing the higher studies without the explicit prior permission of IHRD, or
- (h) on completion of higher studies failing to serve the IHRD for a minimum period of Five Years on such terms and conditions as may be prescribed by the IHRD, or
- (i) failing to conform to the discipline of the IHRD or organization of the IHRD or any Institute, Organisation or body selected by the IHRD where he/she is posted, or
- (j) not conforming or observing to the other rules and conditions subject to which he/she had been deputed for the higher studies, as the bounden and the sureties
