ORDER

Government have sanctioned an amount of ₹ 12 Crores (Rupees Twelve Crores Only) in the Budget for 2013-2014 as Grant-in-aid (read vide 1st cited) to IHRD. Sanction was accorded by Government to release an amount of ₹ 9 Crores (Rupees Nine Crores Only) to IHRD as per ref 2nd cited and released an amount of ₹ 9 Crores to IHRD in the STSB No. 15917 of District Treasury, Statue Branch, Tvp. The Fund has been drawn and transferred to SB Account No 57022834950 as per the directions in the proceedings (read vide 3rd cited). Now an amount of ₹ 450 (Rupees Four Hundred & Fifty Lakhs) is to be released to IHRD institutions viz CEs, CASs, MPTs THSSs & IHRD Study Centres for Purchase of Machinery and Equipments, Furniture, Library Books etc. as detailed below.
