ORDER

Government have sanctioned an amount of ₹ 12 Crores (Rupees Twelve Crores Only) to IHRD in the Budget for 2013-2014 as Grant-in-aid as per ref 1st cited. The Working Group has approved 23 proposals of IHRD as per references 2nd, 3rd, 4th and 5th cited. Government have accorded Administrative sanction for Rs.2324.63 Lakhs and accorded sanction to expend ₹ 12 Crores for 2013-2014. Now the Government have allotted the Plan fund amounting to ₹ 12 Crores which includes ₹ 7 Crores for Construction, ₹ 4.5 Crores for the Purchase of Machineries & Equipments and Library books etc and ₹ .0.5 Crores for Recurring expenditure of MPT's and THSS's.

Government have now released an amount of $\ref{thmodel}$ 9 Crores to IHRD for the above mentioned purposes (read vide 6^{th} cited). In these circumstances stated above sanction is hereby accorded to release an amount of $\ref{thmodel}$ 9 Crores (Rupees Nine Crores Only) as detailed below.
