#### **ORDER**

Government have sanctioned an amount of Rs. 1350 lakhs (Rupees Thirteen Crores Fifty lakhs Only) to IHRD in the Budget for 2016-2017 as Grant-in-aid.

As per the Government Order 2<sup>nd</sup> cited, Administrative sanction has accorded for an amount of Rs. 500 lakhs (Rs.4.85 Lakhs for the Purchase of Machinery & Equipments and Furniture & Fixtures for IHRD HQrs, Rs.453.15 lakhs for the purchase of Machinery & Equipments, Furniture & Fixtures and Library books for the associate institutions, and Rs.42 lakhs for setting up of Mini Fab Labs at MEC Ernakulam and CE, Chengannur). As per IHRD proceedings read as 3<sup>rd</sup> paper above, Administrative Sanction has been accorded for Rs.458 lakhs for the purchase of Machinery & Equipments, Furniture & Fixtures and Library books.

Government have accorded sanction to release an amount of Rs. 500 lakhs to IHRD under the head of account 2203-00-112-60 vide GO cited 4.

Under the above circumstances sanction is hereby accorded to transfer credit an amount of Rs.500 lakhs to the accounts of the IHRD and its associate institutions as detailed below for the purchase of machinery & equipments, furniture & fixtures, library books and for setting up of mini fab labs.
