#### **ORDER**

Government have sanctioned an amount of ₹ 13 Crores (Rupees Thirteen Crores Only) to IHRD in the Budget for 2015-2016 as Grant-in-aid as per ref. 1st cited. As per the Government Order 2<sup>nd</sup> cited, Administrative sanction was accorded for an amount of ₹ 5 Crores for the Purchase of Machinery & Equipments, Furniture & Fixtures and Library books. Administrative Sanction has been accorded to the institutions under IHRD for the purchase for ₹ 5 Crores as per reference 4<sup>th</sup> cited. Government have also accorded sanction to release an amount of ₹ 5 Crores to the head of institutions under the head of account 2203-00-112-60. The amount was deposited on SB Account of IHRD.

As per the proceedings read as 5th paper above, an amount of ₹ 2,42,73,065/-(Rupees Two Crores Forty Two Lakhs Seventy Three Thousand and Sixty Five Only) was sanctioned and distributed to Model Polytechnics Colleges and Technical Higher Secondary Schools, College of Applies Sciences and Extension Centers & Regional Centre's under IHRD for the purchase of Machinery & Equipments, Furniture & Fixtures and Library books. An amount of ₹ 2,49,05,877/-(Rupees Two Crores Forty Nine Lakhs Five Thousand Eight Hundred and Seventy Seven Only) is required for the purchase of machinery & equipments, furniture & fixtures and library books to Engineering Colleges under IHRD.

Under the above circumstances sanction is hereby accorded to release and distribute an amount of ₹ 2,49,05,877/- (Rupees Two Crores Forty Nine Lakhs Five Thousand Eight Hundred and Seventy Seven Only) to the Engineering Colleges under IHRD as detailed below for the purchase of machinery & equipments, furniture & fixtures and library books under Plan Fund 2015-16.
