The Gradation list of Computer Programmer in IHRD as on 01.06.2011 stood published after completing the due formalities, vide reference (1) cited above.

The Government approved the revised Special Rules of IHRD and the same has been implemented with effect from 09.12.2014, vide reference (2) cited above. As per the revised Special Rules appointments upto the post of (Junior Superintendent) and equated categories like Junior System Analyst have to be made by promotion from the respective feeder categories under IHRD service. The promotions will be strictly on the basis of seniority of the feeder category and on the basis of the latest Performance Evaluation Report. The Director, IHRD shall be the selection authority. Under these circumstances the seniority list of Computer Programmer is published for revalidation as on 01.01.2016 and finalisation in the light of revised Special Rules.

The Heads of all IHRD institutions are directed to circulate this to all Computer Programmers under their control. The Head of Institutions should invariably check the service details of all Computer Programmers with their Service Books and confirm whether the incumbents are fully qualified to hold the post as per the revised Special Rules. Objections/complaints /Additions if any, received, may be sent to this office with specific remarks on or before 26th March 2016. Belated petitions will not be considered under any circumstances.
