The selection of faculty members for the above programme will be done by a Screening Committee. The terms and conditions for deputation and selection shall be as mentioned in this office proceedings read (1) & (2) above. No deviation on the terms and conditions already fixed is possible. The regular faculty members who have completed two years regular service as on 01.07.2017 alone are eligible to apply under the scheme. Applications of the employees who have not completed two years regular service under IHRD as on 01.07.2017 need not be forwarded to this office.

The maximum age limit for deputation of faculty members for higher studies is 45 years as on 01.07.2017.

The last date prescribed for the receipt of application in the prescribed format by the heads of the Engineering College is fixed as 02.11.2017. The applications so received by the Principals of Engineering Colleges shall be forwarded to this office duly verified and recommended so as to reach here on or before 10.11.2017. Late applications will not be considered under any circumstances. It may be noted that enhancement of seats if any done subsequently, shall be filled only from the panel prepared based on this notification.

The heads of institutions will circulate this communication among the regular faculty members working under them obtaining dated acknowledgement.

This notification is issued subject to disposal of WP(C) No.19627 of 2015 before the Hon'ble High Court of Kerala.
