CIRCULAR

Sub:- IHRD - Associate institutions - Availing internet connections - guidelines issued

IHRD institutions have been using NMEICT VP NoBB connections during the past several years. Now M/s BSNL Ltd. which is the implementation agency of NMEICT project has informed IHRD that MHRD had discontinued payment of the 75% subsidy for NMEICT connections and that the IHRD institutions has to bear the full cost henceforth. However M/s BSNL has offered 25% discount in the rate for the current year.

Since IHRD is facing acute financial crisis and is struggling to arrange funds even to meet the salary of the employees the heads of the associate Institutions are directed to limit the expenditure relating to internet charges and to choose the internet connectivity for their institutions as per the following guide lines.

- 1. Institutions can opt for Internet connections as per their requirement preferably from Govt. agencies and based on local availability of connection choices.
- 2. The expenditure should be limited to the bare minimum.
- 3. Most of the IHRD institutions are using multiple connections from different service providers like BSNL, ASIANET, RAILTEL etc. in addition to NMEICT connections. It is learned that most of the 512 Kbps NMEICT connections in some Institutions are not being fully utilized. Most of the IHRD Institutions are using NMEICT connection only as a backup line, in the event of failure of other Internet connections. In order to minimise the expenses all the unused connections should be discontinued at the earliest.
- 4. The payment of bills for all internet connections should be made by the individual Institutions hence forth subject to the budget provisions.
- 5. The institutions can contact M/s BSNL directly for taking steps to disconnect unused the NMEICT connections.
- **6.** Since IHRD had paid charges only upto 30.11.2017 for NMEICT connections immediate action should be taken to disconnect the unwanted connections.
