The Hon'ble High Court in the judgment dated 11.01.2017 ordered to consider and pass orders on the representation dated 26.02.2000 of Sri. Abdul Nazar. T and dated 03.03.2000 of Smt. Kadeeja. V.S (i.e Exhibits P2&P3) objections preferred by the petitioners against Exhibit P1 seniority list untrammelled by anything stated in Exhibits P7 and P12 strictly in accordance with the Special Rules which were in force as on the date of appointment of the petitioners as Office Assistants (formerly LDCs). Accordingly, legal opinion has been obtained from our Standing Counsel by this office. On the basis of the legal opinion, hearing was conducted with the petitioners on 08.03.2017 in the IHRD (Headquarters), Thiruvananthapuram .The petitioners requested to revise their seniority in the cadre of LDC with reference to their date of entry into service as Junior Office Assistant under IHRD without considering the select list approved by the Executive Committee. But the Hon'ble High Court specifically ordered that, the review of the existing list shall be strictly in accordance with the Special Rules which were in force

as on the date of appointment of the petitioners as L.D Clerks. As per the Special/Service Rules of IHRD, there was no automatic promotion and the method of appointment prescribed for the post of LDC is "by selection from the post of Junior Office Assistant on merit".

As per the Special Rules applicable to the IHRD employees vide G.O (MS) No. 159/89/H.Edn dated 10.08.1989 clause 2 sub clause (10), "Selection to each post will be done by a Selection Committee constituted for this purpose. While there will be no automatic promotions, the Committee will consider the performance of all internal candidates before making recommendations for the appointments."

As per the Special Rules of IHRD, the method of appointment prescribed for the post of Lower Division Clerk is by selection from Junior Office Assistant with 2 years experience on merit. Accordingly, the Selection Committee was constituted comprising of following members

Applications were invited and all applications were placed before the meeting of the Selection Committee for the post of Lower Division Clerk held on 10.08.1998. Selection Committee prepared the rank list as show below:-

The Hon'ble High Court in the Judgment has reliably made clear that, uncommunicated adverse remarks in the confidential role of the petitioners shall not be relied upon as a ground for denying their seniority in the category of LD Clerk.

By considering all these aspects, the hearing note submitted by the petitioners in the reference read as 5<sup>th</sup> and 6<sup>th</sup> paper above have been examined in detail with reference to the Special and Service Rules of IHRD applicable to the IHRD employees then and also hold a discussion with the Standing Counsel of IHRD and observed that, the directions contained in the Judgment dated 11.01.2017 are specific and strictly in accordance with Special Rules which were in force as on the date of appointment as LDC (re-designated as Office Åssistant). In the above

circumstances, the seniority of Office Assistant, Senior Office Assistant, Head Clerks and Junior Superintendent is to be revised in compliance with the Judgment dated 11.01.2017 of the Hon'ble High Court as shown in the separate sheet attached.

- 2. The Head of institutions concerned shall circulate the notice to the employees working under their control including those on leave and obtain their dated acknowledgment. The judgment should be complied within the time limit. The objection/representations if any received should be forwarded to this office before 29.03.2017 itself along with supporting documents if any for detailed examination by this office unless the above proposed list will be finalized accordingly.
- 3. If no employee included in the list is working in that institution a NIL report shall be furnished within the time limit.
- 4. Receipt of the circular shall be acknowledged by return.
