## ORDER

As per the letter read above, IHRD had requested the Government to take necessary steps to revise the syllabus of technical subjects of Standard VIII to XII in the Technical Higher Secondary Schools managed by IHRD. As per the letter read as 2<sup>nd</sup> paper above on the basis of Government direction, the Director, SCERT had proposed two options in which IHRD has opted to conduct workshops for syllabus revision with pedagogic support from SCERT. Accordingly, IHRD had conducted workshops for syllabus revision with necessary support and guidance from SCERT for the following Technical Subjects of Standard VIII to XII and completed the curriculum and syllabus revision.

- 1. Computer Science and Information Technology
- 2. Electronics
- 3. Electrical Technology

As per the letter read 5<sup>th</sup> paper above, the Director, SCERT, Thiruvananthapuram had forwarded a minutes of 48<sup>th</sup> State Curriculum Steering Committee held on 15.02.2017 along with the revised syllabus for the above mentioned subjects with the approval of Hon'ble Minister for Education.

The revised syllabus approved by the 48th State Curriculum Steering Committee held on 15.02.2017 for the technical subjects for Standard VIII to XII has been placed before the 95th Executive Committee of IHRD and resolved to implement the revised curriculum in the Technical Schools and Technical Higher Secondary Schools under IHRD from 2017-18 academic year onwards as per the minutes read as 5th paper above.

In this circumstance, sanction is accorded to follow revised syllabus for Standard VIII & XI from 2017-18 academic year in the Technical higher Secondary School under IHRD. All Principals of Technical Higher Secondary Schools under IHRD are instructed to take necessary steps to follow revised syllabus from 2017-18 admissions.
