Sub:- IHRD - Arts and Science faculty members in Engineering Colleges - faculty members having insufficient workload - sparing service to other institutions - instructions - reg:-

Ref:- This office Circular of even no. dated 05.09.2018

In this office circular cited above, all Principals of Engineering Colleges were directed to obtain and forward willingness from the Arts and Science faculty members not having sufficient workload as per norms, so as to utilize their service in other needy IHRD institutions as resolved by the 97th meeting of the Executive Committee of IHRD. No willingness was received from the faculty members eventhough last date was fixed on 07.09.2018. It was also intimated that, if no willingness is received within the stipulated time, the matter will be proceeded with according to the requirement of the associate institutions concerned. In this circumstances, the following clusters of institutions are formed so that the head of institutions of Engineering College in the particular cluster can spare the service of faculty members under their control to the needy institutions within the cluster.

The head of institutions of Engineering Colleges are also directed to spare the service of faculty members in Physical Education to other needy institutions based on the request received from the concerned Head of Institutions, under intimation to this office.
