2. Adhoc / Advance release of funds before expenditure becoming due will not be allowed.
3. The total expenditure will be limited to the Current Year's Budget Provision.
- 4.If Computer Purchase is involved concurrence of Store Purchase Department should be obtained.Circular No. 25/16/Fin dated 01.06.2016 should be strictly followed.
5. e-tender ' system should be followed.
6. Store Purchase Rules should be strictly followed.
7. For Construction work , Time of completion should be specified.
8. If accredited agency is executing the works, time of completion along with " penalty clause " should included in Mou / Agreement.
9. For PWD works, PRICE Software should be obtained.

The expenditure shall be limited to the budget provision and the same shall be met from the head of account concerned and the amount should not be used for any other purpose.


The Director, IHRD shall implement the scheme strictly in accordance with the plan write - up observing all the relevant rules.


