As per Clause 11.6.9 of the Prospectus for KEAM 2018 approved via Government Order cited above, it is specified that Spot Allotment/Admission for filling up the remaining vacant seats, if any, may be conducted after completion of the online allotment process, and the Commissioner for Entrance Examinations is authorized to issue necessary orders regarding Spot Admission/Allotment

In this context, I am to inform you that the final online allotment to the vacant seats in Govt.Controlled Self Financing Engineering Colleges and Govt./Govt. Controlled Self Financing Pharmacy colleges was held on 26.07.2018 and the candidates allotted were directed to join the respective colleges on or before 01.08.2018.

As per the orders of the Hon'ble Supreme Court of India, the last date of admission for Engineering/Pharmacy Courses is fixed as 15.08.2018. In the Circumstances, sanction is hereby accorded to the authorities of all Govt. Controlled Self Financing Engineering colleges and Govt./Govt. Controlled Self Financing Pharmacy colleges to conduct Spot Admission to the vacant seats still remaining in these colleges before 5 pm on 15th of August 2018, strictly adhering to Clause 11.6.9 of Prospectus for KEAM-2018 and also following the merit and reservation principles after publishing the vacancies and by giving wide publicity in leading news dailies.
