2) The above incumbents will be on probation in the post of Principal, Technical Higher Secondary School for a period of one year within a continuous period of two years from the date of their actual joining duty. The inter-se seniority of the promotees will be as in the order of seniority as mentioned above.

3) The faculty members/supporting staff holding full additional charge of Principals of Technical Higher Secondary School stands relieved from the additional charge on assuming charge of newly posted Principal.

4) Those who appointed as Principal, Technical Higher Secondary School under IHRD should pass the Account Test (lower)/Executive Officers Test conducted by the PSC within 3 years from the date of joining duty failing which their further increment shall be deferred and such increment shall be restored on passing the test or on attaining the age of 50 years.

5) The head of institutions concerned will relieve the incumbents immediately with instruction to report for duty at the newly posted institutions forthwith.

6) The date of relieving/joining duty of the incumbents will be intimated to this office in due course.

* Sri. Sunil Kumar R (Sl.No. 6) will have to produce all original/ copies of certificates attested by the Gazetted Officer before the undersigned for verification before joining duty unless his promotion stands cancelled.

** Smt. Bindu S. (Sl.No.9) will have to produce equivalency certificate before the undersigned for verification before joining duty unless her promotion stands cancelled.
