ORDER

In the reference read as 3rd paper above, Government revised the Staff Pattern of IHRD institutions. According to the revised Staff Pattern, 12 nos. of excess hands in the cadre of Assistant Professor in Mathematics are working in the Engineering Colleges consequent on conversion of regular posts into temporary one. As per the requirement forwarded by the Principals of Engineering Colleges based on University norms, their services are inevitable. Taking into account of the requirement as per University norms forwarded by the Principals, as well as on the decision of previous Executive Committee/Governing Body, detailed proposal have been placed before the 97th meeting of the Executive Committee for a decision.

- As per the reference read as 2nd paper above, the 97th meeting of the Executive Committee of IHRD held on 9-5-2018 resolved that the present work load forwarded by the Principals of Engineering Colleges as per the KTU norms are sufficient to accommodate all the faculties in Arts & Science subjects in the Engineering Colleges and decided to accommodate all the Arts & Science faculty against the actual requirement of faculties as suggested by the Principals subject to the following conditions:-
 - (i) The Arts & Science faculty members over and above the Government approved Staff pattern will be re-distributed to the Engineering Colleges as per the faculty requirement suggested by the Principals, on the basis of actual workload, over and above the sanctioned posts.
 - (ii) The Principals of Engineering Colleges concerned should ensure that, the faculty so engaged over and above the sanctioned posts as per Government approved Staff Pattern should engage required number of hours per week as per UGC guidelines. If the actual number of hours available in the institution are less than the UGC norms, due to decrease in intake or any

other reasons, the faculty so accommodated over and above the sanctioned post should engage classes in the nearby IHRD institutions (by protecting their pay, till the anomaly is to be rectified by Government) for which detailed proposal shall be forwarded to this office by the Principals concerned with supporting documents prior to the beginning of each semester unless it shall be the risk and responsibility of the Principals concerned.

(3) Taking in to consideration of the decision of the 97th meeting of the Executive Committee of IHRD, following transfer and posting of Assistant Professor in Mathematics in the Engineering Colleges under IHRD are ordered with immediate effect.
