## **ORDER**

In this office proceedings read (1 & 2) above, sanction has been accorded to enhance the consolidated pay of Rs.12,000/- per month from existing pay of Rs.10,800/- with effect from 01..10..2014 and ordered that arrears of pay from 01..10..2014 to 31..12..2017 shall be paid in three instalments on September 2018, January, 2019 and May 2019 subject to the approval of the Hon'ble High Court. One instalment during September 2018 was already disbursed and the Hon'ble High Court ordered to disburse the remaing of arrears befor 31..01..2019. Sanction is accorded to the head of institutions concerned to draw the remaining of arrears (second and third instalment due January 2019 and May 2019) shall be disbursed before 31..01..2019.
