#### **NOTIFICATION**

Sub:- IHRD – Appointment to the post of Lecturer in Engineering/Technology in Model Polytechnic Stream on Rs.39500-83000/- under IHRD by internal promotion – Application called for – Reg:-

As per the revised Special Rules of IHRD approved by Government, the teaching posts have been bifurcated as College of Applied Science stream, Model Polytechnic stream and Technical Higher Secondary School stream. During 2019, Sri. Tojo Sebastin and another filed a W P (C) No. 17571/2019 before the Hon'ble High Court for internal promotion to the post of Lecturer in Engineering/ Technology in the Polytechnics under IHRD in the posts reserved for internal candidate under 35% internal reservation scheme. Without bifurcation of streams the number of vacancies could not be assessed. The 103rd meeting of the Executive Committee of the IHRD held on 30/06/2021 accorded permissive sanction to bifurcate the College of Applied Sciences, Model Polytechnic Colleges and Technical Higher Secondary School after inviting option against the sanctioned post after observing due formalities. Now, the faculty members have been bifurcated as per their option and the vacancy assessed. The Hon'ble High Court in its judgement dated 01.10.2021 ordered to finalise the internal promotion to the post of Lecturer in Engineering/ Technology in the Polytechnic Stream under IHRD. As such, applications to the existing vacancy are called from qualified hands under IHRD service in the prescribed form enclosed for preparing a select list of candidates in order to fill up the vacancies that exists in the post of Lecturer in Engineering/ Technology in the Polytechnic Stream under IHRD as per IHRD Special Rules. There shall be no relaxation with regard to the minimum qualification for the internal selection of candidates.

The qualification and method of appointment to the post of Lecturer in Engineering/ Technology in the Polytechnic Stream under IHRD on Rs. 39500-83000/- is as shown below:-
