IHRD – Sanctioning of Special Casual Leave to employees who undergo Chemotherapy or radiation or heart surgery or organ/kidney transplantation as applicable to Government employees – extended to IHRD employees – Sanction accorded – Orders issued.

<u>ORDER</u>

As per the Government order read above, Government employees are eligible for Special Casual Leave up to 45 days for undergoing Chemotherapy or radiation or heart surgery or organ/kidney transplantation. Several requests were received from IHRD employees to extend the benefits to them also. The matter was placed before the Executive Committee. The 105th meeting of the Executive Committee of IHRD held on 04.07.2022 resolved to extend the benefits of the above Government order to IHRD employees also on the same terms and condition. In the above circumstances, the following orders are issued.

1. Sanction is accorded to extend the benefits of Special Casual Leave up to 45 days to those who undergo Chemotherapy or radiation or heart surgery or organ/kidney transplantation as applicable to State Government employees to IHRD employees also on the same terms and conditions of the Government order.

2. The head of institutions concerned shall sanction Special Casual Leave upto 45 days on production of medical certificate from an authorized Medical Officer in strict compliance of all conditions laid down in the Government order under intimation to IHRD (Headquarters).

G. O. (P) No. 508/2012/Fin. Dated, Thirty ananthapuram, 22nd September, 2012.

S. R. O. No. 665/2012.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

- 1. Short title and commencement—(1) These rules may be called the Kerala Service (Fifteenth Amendment) Rules, 2012.
- (2) They shall be deemed to have come into force on the 26th day of February, 2011.

- 2. Amendment of the Rules.—In the Kerala Service Rules, in Appendix VII, under the heading Section II—Special Casual Leave, after rule 18, the following rule shall be inserted, namely:—
- "19. Employees who undergo chemotherapy or radiation or heart surgery or organ/kidney transplantation shall be granted special casual leave not exceeding 45 days in a calendar year, on production of certificate to that effect from an authorised Medical Officer to cover the actual period required for chemotherapy or radiation or heart surgery or organ/kidney transplantation followed by post transplantation recovery. The leave may be allowed to be combined with the ordinary leave as defined in rule 77 (i) of Part I of these Rules or with ordinary casual leave. The period of leave under this rule shall be exclusive of public holidays that may intervene and the leave may be availed of on more than one occasion in a calendar year, if needed.

Explanation:—For the purpose of this rule, 'authorised medical officer' means.

- (i) The Medical Officers of Government not below the rank of an Assistant Surgeon; and
- (ii) Private Medical Practitioners of modern medicine registered in Part A of the Register of Modern Medicines.".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per G. O. (P) No. 334/2011/Fin. dated 6th August, 2011, the Government have introduced special casual leave for a maximum of 45 days in a calendar year to those employees who undergo chemotherapy or radiation or kidney transplantation. In order to give statutory validity to the said Government Order, Government have decided to amend Section II of Appendix VII of the Kerala Service Rules.

The notification is intended to achieve the above object.
