NOTIFICATION

Sub: - IHRD- Admission to the reserved seat for departmental candidates for M.Tech programme in Engineering Colleges under IHRD during academic year 2023-24 – application called for - Reg:

From academic year 2012-2013 onwards for the M.Tech course conducted by LBS and IHRD 25% of M.Tech seats in each branch has been reserved for sponsored candidates of which one seat in each branch will be set apart for departmental candidates. The departmental candidate shall undergo M.Tech by availing Leave Without Allowance under relevant rules of Part I KSR for the entire duration of the course. No fee shall be charged from the departmental candidate. The departmental candidate shall execute a bond in the prescribed format (attached) stating that they shall serve IHRD for a period equivalent to the period of leave availed for study purpose. The incumbent violating the bonded obligation shall be liable for payment of liquidated damages as fixed by IHRD.

Applications are invited from teaching faculties and technical staff under IHRD in the prescribed format (attached). The qualification and academic eligibility prescribed in the prospectus for each course is applicable to the reserved seat for departmental candidates as well. The order of preference of applications will be

- 1. Teaching faculties of Engineering College,
- 2. Teaching faculties of Non Engineering College.
- 3. Technical staff

The selection will be based upon inter-se seniority in the respective categories. In case of a tie, faculty members of same branch, which offered the course in the given college, will be given preference. Applicants may also opt the course and institution they propose to undergo M. Tech studies.

The details of course and number of seats reserved for each course for departmental candidates in various Engineering colleges under IHRD are as detailed below.

In the event of the bounden

- a. not conforming to the instructions regarding higher studies conveyed to him by the authorities concerned, or
- ь. not conforming to the rules and discipline of the Institute of higher studies or
- c. applying for any post or sitting for any all India or State Government competitive examination during the course of higher studies, or
- d. failing to intimate to the Government the amount and other particulars in respect of any honorarium of other monies earned by him during the period of his higher studies as above, or
- e. refusing to hand over and surrender to the IHRD the whole or part of such honorarium of other monies received by him as aforesaid, if and when required to do so by the IHRD, or
- f. getting adverse report regarding the progress of his/her studies or regarding his/her conduct in and outside the place of higher studies, or
- g. failing to complete the higher studies successfully as aforesaid, or discontinuing the higher studies without the explicit prior permission of IHRD, or
- h. on completion of higher studies failing to serve the IHRD for a period equivalent to the period of LWA on such terms and conditions as may be prescribed by the IHRD, or
- i. failing to conform to the discipline of the IHRD or organization of the IHRD or any Institute, Organization or body selected by the IHRD where he/she is posted, or
- j. not conforming or observing to the other rules and conditions subject to which he/she had been deputed for the higher studies, as the bounden and the sureties shall forthwith pay to the IHRD on demand all monies spent by IHRD on his account by way of tuition fees, plus a penalty at the rate prescribed by the IHRD and interest at the rate of ten percent on the whole amount to be remitted to IHRD in respect of the said higher studies and in the matter of deciding what monies are to be paid by the bounden and the sureties to the IHRD, the decision of the IHRD shall be final and legally binding on the bounden and the sureties and upon the payment of such sum the above written obligations shall be void and of no effect, otherwise this be and remain in full force and effect.

NOTE In case the sureties are not permanent Gazetted Government Servants of equivalent to the status of a Lecturer in Engineering/Technology under regular IHRD service, the Director, IHRD will satisfy himself about the solvency of the proposed sureties, obtaining necessary certificates from the Tahsildar.

PROVIDED however the IHRD may allow the bounden to apply for or avail of any foreign scholarship or any other scholarship in India before expiry of period equivalent to LWA (here enter the period of bonded obligation) of service as a teacher in terms of this bond.
