**ORDER**

The Staff Selection Committee for selection to the post of Senior Superintendent held on 16.05.2023 prepared select list and waiting list of candidates for the post of Senior Superintendents. Accordingly, 12 candidates were already appointed as Senior Superintendent from the list in the associate institutions as per the vacancies available then. At present, there are two vacancies, one each existing at Model Polytechnic College, Kalliassery and College of Engineering, Adoor. As recommended by the Staff Selection Committee, the undermentioned Junior Superintendents on Rs.30700-65400/- are promoted as Senior Superintendents on Rs.35700-75600/- with immediate effect and posted to the institutions as noted against their name.
