IHRD - Temporary promotion of qualified Last Grade Servants to the post of Office Assistant as one time affair – temporary promotion of Last Grade Servant as Office Assistant - Orders issued

### ORDER

As per the G.O. read first paper above Government has accorded sanction for temporary promotion of qualified Last Grade Servants in IHRD (from the direct recruitment quota (80%) to internal promotion) to the post of Office Assistant by relaxing the method of appointment in the Special Rules as one time affair subject to the condition that, temporary promotees will be reverted to their previous posts as and when the direct recruitees join duty. In view of the Government orders and as recommended by the Scrutiny Committee for the post of Office Assistant held on 26.08.2023, the under mentioned Last Grade Servants are temporarily promoted as Office Assistants. On such promotion they are allowed to continue in their present institutions. Orders of their redeployment will be issued later.

- 3. The Office Assistants now promoted on temporary basis shall discharge their duties, responsibilities, office timing etc... on par with the regular Office Assistant till regular incumbents join duty.
- 4. The Office Assistant now promoted on temporary basis shall be considered as Last Grade Servants for all purpose including sanctioned post for their accommodation etc...
- 5. The temporary promotion will become effective only after the incumbents join duty on such posts.
- 6. The date of relief/joining duty of the incumbent shall be intimated to this office in due course.
